Jeff Bezos' Day 1 Family Fund Grants \$1.25 Million To Time For Change Foundation

Time for Change Foundation (TFCF) has been selected by the Bezos Day 1 Families Fund to receive a \$1.25 million grant to help provide much-needed services in the Bay Area and Inland Empire. The Bezos Day 1 Families Fund launched in 2018 to fund organizations that work to provide shelter and other support to families experiencing homelessness.



The Day 1 Families Fund issues annual leadership awards to organizations and civic groups doing this work, and the grants are unique in that there are "no strings attached" to them—we're able to use these funds in the ways that will benefit our community the most. "I'm inspired by TFCF's commitment to re-entry efforts and housing support for previously incarcerated women and their children," said Amazon CEO Jeff Bezos. "I hope that this grant will help continue to serve families in the San Bernardino area during these challenging times." The Bezos Day One Fund has selected Time for Change Foundation (TFCF) and their dynamic leadership team, Kim Carter – Founder and Vanessa Perez – Executive Director to be the recipient of the 2020 Day 1 Families Leadership Award of 1.25 million dollars.

The Day 1 Families Fund issues annual leadership awards to organizations and civic groups doing compassionate, needle-moving work to provide shelter and hunger support to address the immediate needs of young families. Currently, TFCF operates in 17 locations which spans from the Inland Empire to the Bay Area combating the effects of homelessness, family separation and the housing crisis. Since its inception in 2002, TFCF has helped over 1,700 women make the transition from homelessness and incarceration into self-sufficiency. More importantly, we have reunited 299 children from foster care back with their moms via our programs.

TFCF uses a three-pronged approach which includes direct services, advocacy, and community development. Dismantling structural racism and systemic barriers to housing and education while building the community economic infrastructure needed to support low income families is what drives our passion and commitment to this work. "We are overwhelmed with the generosity of the Bezos Family Fund and humbled to know that the Founder of Amazon, Jeff Bezos, has truly committed his philanthropic efforts to helping address the housing crisis and supporting homeless families," says Vanessa Perez, TFCF's Executive Director.


TFCF is one of 42 nonprofits across the U.S. to receive the third annual Day 1 Families Fund grants, as part of a continuing commitment by the Day 1 Families Fund to help end homelessness for families. Josephine's Story

Josephine came to Time for Change Foundation (TFCF) on August 11, 2020 after completing five months at Magnolia Drug Treatment Program. Since 2016 she has lived in various sober livings and has been in six different drug treatment programs throughout Humboldt County. Trying to maintain sobriety had been a struggle for Josephine, but her biggest motivator was her six-year-old son, Michael. Josephine heard about TFCF from another woman in the program and called immediately. When she called the staff conducted her phone screening and she entered into our Brighter Futures home for women and children a week later. Aside from trying to better herself, Josephine battled the child welfare system as she tried to regain custody of her son. Feeling like she was fighting alone, Josephine did everything she had to do to comply with what was asked of her and after only 30 days at TFCF she was able to bring her son Michael home. After two years of separation due to her addiction, Josephine finally got a second chance to be the mother her son needs. With the help of treatment and now having a stable home, Josephine has been able to remain clean and sober for seven months. "I'm so thankful for Time for Change Foundation, my son wouldn't be as happy as he is here anywhere else," Josephine share with us. When asked about what she likes best about TFCF she said, "I love everything about TFCF, everything they offer has helped me, I've been in every program, and nothing compares." Michael loves his new home and expresses to his mom how happy he is now that he's with her. Today Josephine is going back to school to get her GED and Michael is thriving in preschool.

Public Policy Updates

ACA- 6 What ACA-6 means for our clients is that they are now able to restore their right to vote if they are on parole. This is big deal as our client's voices need to be heard with their vote!

Senate Bill 555 will limit the amount that a county jail can charge for commissary and telephone calls. This bill helps our clients in jail or prison as it reduces their cost for making phone calls and personal use items without being overcharged for them.

Assembly bill 1196 is to stop the deadly force of a peace officer. A law enforcement agency shall not authorize the use of a carotid restraint or choke hold by any peace officer employed by that agency. There are other way to make an arrest without taking a life or using deadly force. This bill was in response to the death of George Floyd.
